*Ontario lawyers now have a tool that lets them reduce the time it takes to undertake real estate transactions by as much as 50 per cent: That tool is RealtyPLUSWeb – a fully integrated, Web-based, one-stop technology platform that brings the paperless office one step closer to reality for those doing real estate transactions.*

Launched late this summer by LawyerDoneDeal Corp. (LDD), RealtyPLUSWeb offers real estate lawyers many advantages over other real estate tools currently in use:

- **State of the art file management and document production:** RealtyPLUSWeb integrates all of the capabilities needed in a real estate practice into one program. Information entered into the system automatically pre-populates the many forms and documents used in a transaction. Online access to a variety of databases – including a database of updated real estate precedents – lets lawyers bring knowledge of the latest legal developments to each transaction. The program also generates a number of management reports, and enables users to track the status of each real estate transaction anywhere, anytime.
- **Complete integration and connectivity with online tools:** RealtyPLUSWeb lets lawyers import and export data from e-reg™ and POLARIS, making it easy to search, retrieve and upload data and documents which then are easily integrated into transaction-specific files and documents.

RealtyPLUSWeb also provides lawyers with online access to selected bank/lender documents (such as mortgage rates, instructions) and builders' closing packages. In addition, users enjoy access to a database of information on specific new

home or condominium projects, many of which may also be enrolled in the TitlePLUS New Home Program. This information – such as the project's legal description, builder information, title data, etc. – automatically pre-populates the RealtyPLUSWeb file, providing yet another level of integration that sets RealtyPLUSWeb apart.

RealtyPLUSWeb is also integrated with an application for optional title insurance. Lawyers who opt for the TitlePLUS insurance product, for example, will see their applications processed seamlessly without duplicate data entry.

- **ASP model:** Because it is developed on an application service provider (ASP) model, RealtyPLUSWeb eliminates the need for lawyers to install upgrades to real estate software on their office networks and work stations. The software that is backbone of RealtyPLUSWeb resides on LDD's servers, ensuring lawyers always have access to the latest technology and information without the associated software and maintenance issues. All communication between lawyers' computers and LDD is encrypted, to ensure the security of data is protected.

"With RealtyPLUSWeb, lawyers are poised to complete a real estate transaction electronically, from start to finish," says Maurizio Romanin, President of LDD, which developed RealtyPLUSWeb.

"In the competitive, price-sensitive world that is real estate practice, lawyers need to be as efficient and cost-effective as possible – while also able to capitalize on e-reg™ and the many other online services now available," he said. "We believe RealtiPLUSWeb meets this need: It puts the lawyer in control – as quarterback in the transaction – and helps ensure lawyers play a pivotal role in real estate conveyancing in Ontario."

This lawyer-centered orientation reflects TitlePLUS's own commitment to real estate lawyers and their practices, and is the principal reason behind the collaboration between LawPRO

# RPWeb shaves 30 minutes off each transaction

Even though it was mid-summer and the middle of the busiest selling season; even though she had never used an online application before; even though she had to teach herself where things were on the various screens; after only one deal Bobbi Brescacin vowed she'd never use anything but RealtiPLUSWeb.
