



## Kathleen A. Waters to receive OBA Award of Excellence in Real Estate

Toronto – May 24, 2016 - On June 22<sup>nd</sup>, the Ontario Bar Association will present LAWPRO President and CEO <u>Kathleen A. Waters</u> with the Award of Excellence in Real Estate.
